## Alloquent™ ALIF Allograft Instrument System

<u>Description:</u> The Alloquent<sup>™</sup> ALIF Allograft Instrument System allows the surgeon to prepare and measure the intervertebral disc space during a lumbar fusion procedure. Trial sizers, corresponding graft sizes, help the surgeon to choose the appropriate size of allograft for a precise fit. The blade distractor or bullet distractor provide a means of distracting the intervertebral space. The graft holder and tamps will be used to fully place the graft.

The ALIF Allograft Instruments are provided non-sterile, and therefore, must be sterilized before each use.

<u>Cleaning:</u> All instruments must first be cleaned using established hospital methods before sterilization and introduction into a sterile field. Additionally, all instruments that have been previously taken into a surgical field must first be cleaned using established hospital methods before sterilization and reintroduction into a sterile surgical field. Cleaning can include the use of neutral cleaners followed by a deionized water rinse. All products should be treated with care. Improper use or handling may lead to damage and possible improper functioning of the device.

<u>Sterilization:</u> The Alloquent™ ALIF Allograft Instruments are supplied NON-STERILE. Prior to use, all components should be steam sterilized by the hospital using the recommended cycle:

Method: Steam
OR: Method: Steam
Cycle: Gravity
OR: Method: Steam
Cycle: Prevac

Temperature: 250°F (121°C)

Exposure Time: 30 minutes

Temperature: 270°F (132°C)

Exposure Time: 8 minutes
